Background

The agriculture and agribusiness sector are the mainstay of the Indian economy, supporting employment and improved livelihoods for all stakeholders involved. Maharashtra is one of the leading fruits and vegetables producing states in India. It has emerged as one of the country's largest exporters of fruits and vegetable crops. In terms of production, the State accounts for 11% of total fruits and 5% of total vegetables produced in the country. Despite ample opportunities for Maharashtra's horticulture growth that contributes to poverty reduction of farmers, they face challenges related to the agricultural sector's structural issues such as small and marginal land holding, lack of access to direct marketing and interference by middlemen. This leads to below par returns for the farmers in the state.

About MAGNET: The Government of Maharashtra in association with the Asian Development Bank (ADB) is co-financing Maharashtra Agribusiness Network Project (MAGNET) to upscale the development of horticulture sector and agribusiness in Maharashtra. The project core objectives are to increase farmers' income, support value addition, reduce post-harvest losses, increase farm productivity, and mainstream opportunities for rural women lower caste to alleviate rural poverty. The project aims to focus on 15 targeted horticulture value chains which includes, Banana, Okra, Pomegranate, Guava, Orange, Sweet Lime, Sapota, Custard Apple, Strawberry, Green and Red Chilies, Flowers, Mangoes, Lemon, Cashew and Snake Gourd.

Components of the Project: The focus of the project is on 3 core outputs namely: **Output 1**: Institutional capacities of agribusiness institutions and farmer producer organizations strengthened.

Output 2: Financial and agribusiness capacities of farmer producer organizations and value chain operators strengthened.

Output 3: Agriculture value chain infrastructure improved and operational for the target horticulture crops.

Relevance of Fruit Care Activities

One of the key outputs of the project is institutional, technical, and marketing capacity building of FPOs, which envisages facilitating FPOs with best practices in agricultural production for ensuring food safety and quality. Thus, encouraging farmers to adopt fruit care practices and connecting them to regional and international markets has proven to be crucial for a successful food system transformation. Presently Value chain operators/exporters carry out fruit care activities on field. Adoption of fruit care practices by farmers will also help value chain operators to increase export potential of fruits from the selected clusters.

Importance and Potential of Fruit care practices for:

A) Producers:

- to improve quality and productivity by reducing fruit loss during the production
- to get better price for the produce due to quality of fruit gained.
- to gain access to international markets through export quality of fruits.
- B) **Other value chain stakeholders:** in enhanced qualitative and quantitative sourcing of fruits that addresses all major consumer demands.

Beneficiaries

- Member farmers nominated by Farmer Producer Organizations (FPOs)1 and Value Chain Operators (VCOs)2 who are eligible for Matching Grant proposals scrutinized by PIU
- Member farmers nominated by Anchor FPOs identified under MAGNET project.
- Farmers nominated by Institutional Buyers who have signed MoU with MAGNET under Market Linkages.
- SAUs / KVKs / COEs identified under MAGNET project

Selection Procedure


A. Application Form

- The guidelines will be published on MAGNET website and proposals from eligible FPOs and VCOs will be received.
- The applicant will need to furnish the application form as per prescribed template along with necessary documents (Annexures, undertakings etc.)
- The list of beneficiary farmers is to be submitted with application form (Annexure 3)
- The proposals will be selected for financial assistance on a first come basis and proposals will be accepted until the project targets are met.

¹ FPOs: farmers organizations registered under The Companies Act or State Co-operative Society Act, or such Farmer Groups/ Cluster Level Federations (CLFs)/ Community Managed Resources Centers (CMRCs) registered with ATMA/MSRLM/MAVIM. This category may also include Cluster Level FPO Federations/Associations.

² VCOs may include aggregators/processors/ exporters/mid- and large-sized retail organizations/Ag-tech or Fintech organizations working actively with producers and their collectives of any horticultural commodities.

B. Evaluation

A single stage evaluation of the proposal will take place in the technical committee.

Post approval from the Technical Committee, the Project Director, MAGNET will issue administrative approval order to the proposal sanctioned by the Technical Committee.

Pattern of Assistance

- The project will provide 50% subsidy on total equipment cost for fruit care management to 5% of farmers from each selected FPO, subject to a ceiling of Rs. 25,000 per farmer.
- In case of VCOs, the farmers nominated by the VCOs will be provided 50% subsidy on total equipment cost for fruit care management subject to a ceiling of Rs. 25,000 per farmer. Each VCO can nominate not more than 10 farmers as potential beneficiaries.
- The disbursement of the subsidy proceeds to the sanctioned beneficiary organization will take place in single instalment after producing the invoices of expenditure made as proposed towards fruit care activities

Fruit Care Practices for Banana

Nature of Problem Banana fruit

Bunches are generally exposed to biotic and abiotic stresses resulting in poor quality of bunches and less weight. Inconsistent size and presence of black spots on the fruit skin are very common and that fetches lower price.

Common fruit care practices

A. Skirting Bags

Skirting bags are used to cover and protect the fruit from insect attacks, while also allowing water & air to pass through, all at an affordable cost. In case of banana particularly, the use of Fruit Cover bag/ Skirting bag gives the following advantages:

- Bagging protects banana bunches from pest attack, fungi, bacteria attacks, and monkey menace.
- Hands are free from black spots.
- Increase in yield by 2 to 2.5 kg per bunch.
- Harvest maturity achieved earlier by an average of 10 days.
- Uniform size of fruits

Skirting bag specifications:

Transparent and perforated polythene bag with 2% (during cool season) – 4% (during summer season) ventilation may be used to cover bunches.

As per recommendation polythene bag with 2 to 6% porosity can be used.

These bags are fabricated to the size of 0.8m X 1.2m. It is also available as a tube in roll form.

How to use:

- 1. Skirting should be done three months before the harvest.
- 2. Both the ends should be tied.
- 3. If handled carefully, bags can be used for 2-3 harvests.

Eligibility for proposals

Eligible Components

- Labour cost for implementation of identified specific Banana Fruit Care Activities for quality Banana fruits production: Bud Injection, Bunch Sprays, Fruit Obstacle Removal, De-flowering, Removal of False hands, Bell removal, Placement of bunch bag (Skirting Bags).
- Cost of Skirting Bags (Bunch sleeves)
- Chemicals for bud injection & initial bunch sprays
- Activities listed in Annexure 4 are prohibited
